INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF U3A SAFFRON WALDEN

I report on the accounts of the Charity for the year ended 31st July 2020, which are set out on page attached.

The procedures undertaken do not provide all the evidence that would be required in an audit and, consequently, I do not express an audit opinion on the view given by the accounts.
